The Real Reason Egg Prices are So High

Some have blamed the recent spike in egg prices on price manipulation and collusion, but research shows that since February 2022, 44 million commercial layers (birds) have been lost to avian influenza, better known as bird flu. This, along with higher production cost, is the likely cause.

The analysis indicated claims of unfair pricing might not be warranted given the impact of the price of natural gas,

feed cost, and bird loss. Baker affiliate Andre Muhammad's latest article shows economic factors, particularly on the production side, sufficiently explain current egg pricing. <u>READ</u>

When a data set of K-12 public school district superintendents across four years was utilized, it showed turnover among superintendents has increased, largely among men, and women seldom filled those positions – keeping the gender gap as it is.

### Covid- 19 Study

During the pandemic, Tennesseans were most likely to trust information from the <u>CDC</u> on vaccine safety followed


by their own doctor or healthcare provider, according to a survey with more than 9,000 responses. Tennesseans also indicated that seeing or knowing that their own doctor or healthcare provider had received the vaccine would increase their confidence in its safety. Based on these findings, the CDC and healthcare providers are important

messengers in addressing public concerns about vaccine safety.

Additional results of this survey are analyzed in an article co-authored by senior director Dr. Katie Cahill, "Perceptions of the impact of COVID-19 in Tennessee, <u>USA</u>: a retrospective study," which has been accepted for publication in the journal <u>PeerJ</u>. The article analyzes data collected as part of the <u>Tennessee Pulse Survey</u> for Gov. Bill Lee's Economic Recovery Group, which was an effort by the <u>Coronavirus-19 Outbreak</u> <u>Response Experts (CORE-19)</u>.

The article was written in collaboration with lead author Dr. Tamara Chavez-Lindell (TN Dept. of Health), Dr. Agricola Odoi (Veterinary Medicine), and Dr. Kristina Kitzinger (Public Health).

As an expert in international conflict and maritime disputes, Global Security director Krista Wiegand published her most recent book <u>The Peaceful Settlement of</u> <u>Territorial and Maritime Disputes</u>.

Co-authored with professor of political science and Concurrent Professor of Law at the University of Notre Dame Emilia J. Powell, the book provides a deep insight into the South China Sea dispute arbitration process, mainly between the Philippines versus China, explaining how the goals of states who engage in territorial and

maritime disputes are to reduce uncertainty and win in negotiations, mediation, or legal cases.
