INTRODUCTION

Representatives from Macon County met with staff from the Upper Cumberland Development District and the TDEC Office of Outdoor Recreation to discuss possible grant funding for Parks and Recreation development. Participants discussed the development and maintenance of parks and recreation facilities and programs throughout Macon County. Officials learned that to be eligible for grants offered through the Office of Outdoor Recreation of TDEC, applicants **must** have a current Parks and Recreation Systemwide Plan. This plan will attempt to satisfy that requirement and serve as a guide for the community

Why was this plan created?

Shortly after learning that Macon County would need a systemwide plan to be grant-eligible, Macon County Mayor, Steve Jones, received a phone call from Lucas Johnson, a Macon County native and a student in the Master of Public Administration (MPA) program at the Baker School of Public Policy and Public Affairs at the University of Tennessee, Knoxville.

During that phone call, Johnson asked that Mayor Jones assign a project that could be **completed for academic credit**, a requirement for the MPA program at UTK. Mayor Jones realized that this would be a great opportunity to 1) help a student from Macon County achieve an academic goal, and 2) take a step toward a better-prepared, grant-eligible Macon County.

All parties understood the development of the plan in the prescribed timeline would take coordination and a focused effort by all involved. Support by Lafayette, Red Boiling Springs, and Macon County leadership, staff, boards, and citizens have made the completion of this document possible. The high level of involvement by the community ensures the result is a document developed by and for the residents of Macon County.

What does this plan achieve?

The planning process included a strategic planning focus group, a community needs assessment survey, a facility inventory and conditions report, a list of offered programs, the identification of short-, mid-, and long-term goals, and lots of public input. These components and others contributed to a document that will be useful for the maintenance and development of recreational services in Macon County, Tennessee, for years to come.

Public Input Meetings: Community meetings to gather feedback to ensure the plan reflects public priorities and addresses the needs and desires of the public.

Facility Inventory and Conditions Summary: An analysis of the current parks and recreation infrastructure in Lafayette, Red Boiling Springs, and Macon County, identifying advantages, disadvantages, and opportunities for improvement.


Program Offerings: Recreational programs, leagues, and events tailored to all age groups, fostering a stronger sense of community and improving the quality of life.




Macon County


Population Trends & Projections

According to the University of Tennessee's <u>Boyd Center for Business & Economic Research</u>, **the population of Macon County is expected to grow by nearly 4,500, or 17 percent**, between 2022 and 2035. Additionally, the Boyd Center projects population growth through 2070, as shown in the chats below. It is important to account for this projected growth in this plan and others. **The current population is around 25,400**.



Age Data & Trends


According to the University of Tennessee's <u>Boyd Center for Business and Economic Research</u>, **the median age of Macon County citizens will be 37.8 years in 2035** which is consistent with the current median age of 37.9 years. There is a good mix of all ages, however. The county must account for all age groups in planning for the future. The county must provide safe, outdoor opportunities for recreational activities for all ages. The figures below are projections for 2035.



Health Data

Public parks and recreation facilities are essential to promoting physical activity and improving community health. These spaces provide accessible locations for exercise, sports, and recreational activities, encouraging people of all ages and fitness levels to be active. Research consistently shows that access to outdoor recreational spaces can reduce stress, enhance mental well-being, and lower risks of chronic diseases such as heart disease, obesity, and diabetes. Parks and trails also offer a safe environment for activities like walking, running, biking, and group sports, which fosters social connections and builds a sense of community. By prioritizing well-maintained, inclusive, and inviting outdoor facilities, the county can contribute to the physical and mental health of residents, creating a foundation for healthier, happier, and more connected communities.

According to <u>County Health Rankings & Roadmaps</u>, Macon County falls below the state and national averages for health outcome and health factors. This joint city/county plan will help address these outcomes and factors through the use of parks and recreation.







SMITH COUNTY

Regional Context

Macon County offers a rich array of natural and manmade recreational resources that serve as a strong foundation for outdoor activities and community engagement. Situated on the edge of the Highland Rim, the county's rolling hills and hollows provide ample opportunities for hiking, birdwatching, and other nature exploration. This can be explored in the Winding Stairs Park of Lafayette. The mineral waters of Red Boiling Springs add another unique element, drawing visitors with their historical significance and potential for nature walks and quilt trails.



Macon County's **neighboring counties enjoy a plethora of water access, and existing trails** in Macon County and neighboring counties present further opportunities for development, particularly through connections to broader regional networks. Linking these trails with greenways and blueways in neighboring counties in the long term could foster interconnected recreational systems, boosting tourism and encouraging outdoor activity. Potential partnerships around the Cumberland River and primarily its tributaries can extend the county's water-based offerings, while regional trail connections could make Macon County a destination for extended hiking and biking excursions. Macon County's blend of natural beauty, historic landmarks, and modern recreational facilities positions it as a potentially vibrant destination for outdoor activity, with strong potential for growth through regional connectivity and thoughtful expansion of its recreational assets into neighboring counties.

PROGRAM OFFERINGS

In this context, programs are generally defined as any organized activity facilitated within the parks and recreation system. This can include classes, camps, special events, sports leagues, or any other activity that is offered by the county, city, or a private or nonprofit organization within the community. Programs play an important role in the community, serving as athletic, recreational, historical, educational, and cultural **opportunities and activities**. They often utilize public facilities and encourage public use or private development of other community assets.

A well-rounded inventory of parks and recreation programs is crucial for understanding the scope of current offerings and identifying gaps, redundancies, or expansion opportunities. This **program list** serves as a working foundation for the planning and development of future parks and recreation programs by the cities, county, or private groups.

By cataloging the existing programs, we gain insights into community engagement, usage patterns, and the overall effectiveness of current services. This analysis allows us to make informed decisions that align with community needs and enhance the quality of life for residents. It serves as a critical tool for strengthening grant applications and fostering community engagement by demonstrating a commitment to **evidence-based planning**. Overall, current and future programs will promote community well-being, health, and social cohesion.

To garner the necessary public input for this plan, several types of public engagement were utilized including forming a strategic planning group, interviewing staff and stakeholders, holding public input meetings, and conducting a community needs assessment survey.

S.W.O.T. Analysis Workshop

The team held a Strengths, Weaknesses, Opportunities, and Threats (SWOT) workshop on September 19, 2024, with a focus group of stakeholders. This meeting was conducted in person at Lafayette City Hall to maximize the potential input and fully capture the thoughts and views of attendees. The input provided during the SWOT workshop is integral to the strategic planning process and is used in conjunction with interviews, public input meetings, and survey data to get a range of public and stakeholder input to later use in the development of goals and priorities.

Citizens were also invited to bring up new topics at various points throughout the meetings. Finally, the citizens were asked to submit a **comment card** sharing other thoughts relevant to the local parks system. All public input was recorded, and participants were reminded that a public input session would be held again at the presentation of the final draft.

Staff and Stakeholder Interviews

Meetings and phone calls with staff and project stakeholders were held at various times throughout the planning process to collect valuable insight into the existing parks and recreation system, upcoming projects, and potential future needs. Many provided positive feedback about the parks system in their locality, also detailing the struggles that often come with planning for and maintaining a recreation system for a population with varying needs. All participants understood the importance of parks and recreation to quality of life and community interaction. Given the topics discussed in these interviews, there seems to be lots of need for growth and enhancement of the parks and recreation system in the county.



Staff and stakeholder interviews are critical for developing a comprehensive and effective parks and recreation plan, as they provide expert insights and a deeper understanding of operational challenges, resources, and opportunities. Staff members who are directly involved in the day-today management of parks can offer valuable perspectives on current conditions, maintenance needs, and logistical constraints. Meanwhile, stakeholders such as local government officials, community organizations, and civic leaders bring a broader view of the community's goals, priorities, and potential funding sources. These interviews help ensure that the plan aligns with both the practical realities of park management and the long-term vision of the community, fostering collaboration and building support for the plan's implementation. By engaging both staff and stakeholders, we can create a plan that is both feasible and responsive to the needs of the entire community.

Community Needs Assessment Survey

One key strategy for collecting public input was a community needs survey. The survey was created and distributed by various means, including digital distribution on social media, government websites, and email. Additionally, flyers were posted in public places and at all public input and focus group meetings. This survey is a critical component of collecting public input. **Over 300 responses were received** across 42 days of the survey being open for responses. The survey was periodically reposted, shared, and refreshed over the 42 days, and social media engagement, such as comments on posts, was also noted. The survey was created using the Qualtrics platform. The results are summarized in the section below. This survey was extremely helpful in developing goals and priorities.



The public survey included 18 questions that were grouped into 5 categories.


Survey Results: Facility & Amenity Usage



Why visit local parks?




Survey Results: Future Facility & Amenity Usage







Survey Results: General Comments

Responses to the General Comments section of the survey indicate a mix of positive sentiments and constructive criticism regarding parks and recreation in Macon County. Many community members appreciate the existing parks, recognizing them as well-maintained and valuable for the community's health and enjoyment. However, several respondents expressed concerns about safety, accessibility, and maintenance, particularly in specific parks. Comments also highlight a desire for increased security, cleaner facilities, and more inclusive amenities for both youth and seniors. There is also a strong demand for additional recreational options, like indoor facilities, a civic center, or spaces for diverse activities such as skateboarding, pickleball, and others. Several people advocate for improving current parks over developing new facilities and express concerns about tax dollar usage and local infrastructure priorities.



General Comments from the Public Survey:

"I think the parks are well maintained."

"The little league field needs to be handicap accessible and it's not even close!"

"We need more options of places to attend for kids to play and exercise safely. Indoor skating rinks, bowling area, workout facility with indoor/outdoor pool, etc."

"Macon County has an opportunity to have some great parks. Just need the funding."

"We desperately need something like the Gallatin Civic Center or Lebanon's Jimmy Floyd Center."

"We need more activities for preteens and teenagers such as a skateboarding park or a splash pad like Lebanon." Below is a selection of comments that reflect common themes collected from the survey:

1. Safety and Security:

"Keeping everyone safe while enjoying the outdoors. Lots of lighting and security."

"Would love parks to have a heavier police presence."

2. Maintenance and Cleanliness:

"Bathrooms need to be updated. Winding Stairs could use a fuller pond."

"The restrooms' cleanliness and having dogs in the same areas as kids are concerns."

3. Indoor Facilities and Year-Round Recreation:

"We really need something indoors like the YMCA so you have something all year round."

"An indoor facility with an Olympic pool would provide students competitive sporting opportunities."

4. Accessibility and Inclusivity:

"The little league field needs to be handicap accessible, and it's not even close!"

"ADA bathrooms and adult changing tables would be helpful."

5. Expanded Amenities and Activities:

"Indoor skating rinks, bowling areas, and a workout facility with indoor/outdoor pool would get kids more involved."

"Something else for the youth to do would be nice, maybe archery or skateboarding."

Concerns about security, accessibility, and community pride reflect the community's commitment to creating safe, enjoyable, and accessible parks for all ages. By integrating public feedback, this plan can better respond to local values, helping to ensure that our parks not only meet present needs but also foster a vibrant and welcoming environment for future generations.

"My main concern is upkeep on the walking trails, weeds are growing up in the gravel at Key Park. My husband and I walk daily, and the weeds & grass make it more difficult, as well as the trash, bottle & cans lining the park lately. There are a lot of seniors who use this park for the walking trails, but lately people are racing their bikes along the trails. Also, the new metal bridges make it difficult for seniors with walkers and canes, the older bridges were easier to use, and more appealing to the eye, as well as safer."

"Security needs to be stepped up somehow just because of vandals. They seem to ruin everything."

"We need a sports facility. Our facilities are lacking at best. We have all kinds of parks to go walk in a circle or throw a frisbee. We need something for kids that is nice and can hopefully engage other/more kids to get involved."

Other park improvement projects are already in the planning stages, and there are several mid to long-term projects that will be on the horizon soon.

The following list of goals and priorities was identified through the analysis of the vast amount of public input we received via the survey, public meetings, interviews, and elsewhere. While these are not the only goals and priorities, they are among the most important. In pursuit of **promoting healthy lifestyles**, **expanding and enhancing recreational opportunities**, strengthening community ties, supporting economic development, and ensuring sustainability, Macon County, Lafayette, and R.B.S. hopes to increase the overall quality of life for all who use these facilities and programs.

FUNDING OPPORTUNITIES

The grants below are only listed to give readers an idea of the available potential funding options. They are not guaranteed funding but should be considered for future projects.

Office of Outdoor Recreation, TN Dept. of Environment and Conservation

The Local Parks and Recreation Fund (LPRF) provides grants to eligible local government entities for the purchase of lands for parks, natural areas, greenways, and recreation facilities. The funds may also be used for trail development and capital projects in parks, natural areas, and greenways. At least 60 percent of the funds allocated will go to municipal governments as authorized by TCA 67-4-409. All grant projects must be on publicly owned land.

Eligible Applicants: City or county governments

Eligible Projects: Land acquisition, indoor and outdoor recreation facilities, trail development

The <u>Recreational Trails Program (RTP)</u> is a federal funded, state administered grant program. RTP provides grant funding for land acquisition for trails, trails maintenance and restoration/rehabilitation, trail construction, and trail head support facilities. All grant projects must be on publicly owned land.

Eligible Applicants: Local, state and federal government agencies, state-chartered non-profit agencies with 501(c) (3) status that have written agreement with a government agency for trail management.

Eligible Projects: Urban hard surface trail development and natural surface trail development (construction and maintenance), restoration of trails damaged by use, development of trailside support facilities, educational and safety trail trainings.

The <u>Tennessee Recreation Initiative Program (TRIP)</u> provides grants to those cities and counties currently without a comprehensive parks and recreation delivery system in operation due to lack of staffing and organization.

Eligible Applicants: City or county governments.

Eligible Projects: Development of a formal Parks and Recreation Department.

BlueCross BlueShield of Tennessee Foundation

The <u>BlueCross BlueShield of Tennessee Foundation's Healthy Places Program</u> is an initiative designed to provide funding and support for the creation and enhancement of public spaces across Tennessee. The program aims to improve community health and well-being by developing areas that encourage physical activity, social connection, and outdoor engagement.

The Foundation makes grants available to build or upgrade spaces like parks, playgrounds, fitness trails, greenways, and other recreational amenities, focusing on accessibility, safety, and community inclusion. The initiative reflects the foundation's commitment to fostering healthier lifestyles and reducing health disparities by making it easier for communities to have safe, enjoyable places to play and exercise.
